

CA Legacy of Giving Back

ORGINS OF THE ALEXIS DE TOCQUEVILLE SOCIETY

Alexis Charles-Henri de Tocqueville was only 26 years old when he came to the United States and Canada in 1831, recording his observations of life in the young nations. Though he only spent nine months in North America, he gleaned many profound insights about American society. His observations, readings and discussions with eminent Americans formed the basis of Democracy in America, a detailed study of American society and politics, published in two volumes in 1835 and 1840.

Tocqueville recognized, applauded and immortalized North American voluntary action on behalf of the common good. He wrote: "I must say that I have seen Americans make a great deal of real sacrifices to the public welfare; and have noticed a hundred instances in which they hardly ever failed to lend a faithful support to one another," eloquently capturing the essence of personal philanthropy that persists almost two centuries later.

The observations on philanthropy Alexis de Tocqueville made in 1831 remain true today: Advancing the common good means creating opportunities for a better life for all. The society's name was chosen because of Alexis de Tocqueville's admiration for the spirit of voluntary association and effort toward its advancement.

ORGINS OF THE TOCQUEVILLE SOCIETY IN HALL COUNTY

By the fall of 1995 the Leadership Circle made up of donors giving \$1,000 to \$5,000 to United Way of Hall County was in its 7th year and had grown to 185 members. A group of Hall County leaders met with Joyce Wilbur from United Way of America and made the decision to begin an Alexis de Tocqueville Society in our community.

Austin and Barbara Edmondson volunteered to be the first members and Austin enthusiastically stepped into the role of chairman of the new society. On November 16, 1995, Marvin Schuster, chair of the Tocqueville Society in Columbus, Georgia, accompanied Austin and Anna Gines, Executive Director of United Way, on several visits with prospective members. That evening, at the Annual Leadership Circle Reception, Austin and Marvin announced the names of the **six charter members of the Tocqueville Society of Hall County.**

By 2002, under Austin Edmondson's leadership, 28 members had been recruited resulting in \$1,280,000 in donations for United Way to make Hall County a stronger, safer and healthier community.
